

- (b) Any submission by Parties relating to specific issues concerning difficulties in implementation of or compliance with the Convention;
 - (c) Undertaking a Committee initiative.
- 3. The Committee will be briefed by the Water Convention focal points from Montenegro and Albania on progress made with the implementation of the Committee's legal and technical advice under advisory procedure WAT/IC/AP/1 (ECE/MP.WAT/IC/2021/1, annex). It may hold further consultations with the two countries.
