

# II. Annotations to the provisional agenda

The Working Group on Implementation is expected to review national implementation reports, received for the tenth round of reporting on the Convention, and to plan its work for the period up to the next meeting of the Conference of the Parties.

This provisional agenda was prepared by the United Nations Economic Commission for Europe secretariat in agreement with the Chair of the Working Group.

## 1. Opening of the meeting and adoption of the agenda

## **Expected timing: 10 minutes**

The Chair of the Working Group on Implementation will open the meeting and invite the Working Group to adopt its agenda as set out in the present document.

The secretariat will inform members of the Working Group about the planned schedule for the teleconferences at the meeting.

## 2. Review of the national implementation reports

## (a) Analysis of the national implementation reports

## **Expected timing: 6 hours**

In line with Decision 2016/2,<sup>1</sup> all Parties and other reporting countries were requested to submit their implementation report by the deadline, 31 October 2023, for the tenth reporting round (2019–2022). The secretariat will brief the meeting on the timely and late receipt of reports from Parties to the Convention and non-Parties. The Working Group may wish to discuss if any steps should be taken to encourage those countries that did not submit an implementation report to do so.

Members of the Working Group will be invited to present their assessments and conclusions<sup>2</sup> of the sections which were assigned to them. At a previous meeting, the Working Group decided to divide the work on reviewing the national implementation reports according to the sections of the reports, as follows:

# 3. Preparation of the tenth report on implementation

## **Expected timing: 30 minutes**

The Working Group will discuss the next steps, including responsibilities and deadlines, for drafting the tenth report on the implementation of the Convention, based on the findings discussed at the meeting and the written inputs by the Group members. For its further planning, the Working Group may wish to bear in mind the following:

(a) The envisaged holding of another meeting of the Working Group on 29 to 30 May 2024 to review and finalize the draft report on implementation;

(b) The availability of the draft report for the next meeting of the Bureau (Geneva, 12–13 June 2024);

(c) The limit of 10,700 words for the report to be issued as an official document for the 13<sup>th</sup> meeting of the Conference of the Parties (Geneva, 27–29 November 2024, tbc).

The Working Group may also wish to discuss to which extent the areas for follow-up identified in the ninth report on the implementation of the Convention have been addressed and whether further actions should be taken in this regard.

## 4. Strengthening the implementation of the Convention

# (a) Assessment of the need to update the Convention and/or identification guidelines with regards to tailings management facilities

### **Expected timing: 60 minutes**

The Conference of the Parties, at its twelfth meeting (Geneva, 29 November–1 December 2022), mandated the Joint Expert Group on Water and Industrial Accidents (JEG), in cooperation with the Working Group on Implementation (WGI) and the Bureau, to assess in the next biennium, whether there exists a need for *the Guidelines to facilitate the identification of hazardous activities for the purposes of the Convention* to be revised and updated in order to cover more comprehensively the hazards and risks arising from tailings management facilities (TMFs), and to share its findings in the form of an official document with the Conference at its thirteenth meeting.

The Working Group will be invited to review the draft official document and draft elements for a related decision for the thirteenth meeting of the Conference of the Parties, as prepared by the small group on mine tailings safety, and to provide comments and inputs for improving these, in advance of the Joint Expert Group on Water and Industrial Accidents, the Bureau and the small group on mine tailings safety further reviewing and eventually finalizing them.

# (b) Establishment of an interactive network for the exchange of information and sharing of experiences

### **Expected timing: 30 minutes**

At its Special Session: Seminar on Good Practices and Lessons Learned in Implementing the Convention, the Working Group also recommended the establishment of an interactive network for the exchange of information and sharing experience about the implementation of the Convention. At its forty-seventh meeting, the Working Group agreed to pursue the network through the development of an e-group email list —containing the contacts of all Focal Points, officeholders and the Joint Expert Group— which would allow all members on that list to receive and write messages. The Chair of the Working Group, representing Sweden as the lead Party for this activity, agreed to draft a message to initiate this group.

The secretariat will provide a brief update on the technical work completed in developing the e-group and foreseen next steps. The Working Group will be invited to reflect on the next steps and methods to managing the e-group once launched.

# (c) Development of a guide of good practice on the implementation of the Convention

### **Expected timing: 30 minutes**

At its Special Session: Seminar on Good Practices and Lessons Learned in Implementing the Convention (Geneva, 3-4 February 2022), the Working Group recommended the development of a UNECE Guide on Good Practices in Implementing the Industrial Accidents Convention. The Convention's 2023-2024 workplan subsequently entailed an activity to develop a guide to explain the provisions of the Convention, including their scope, limitations and practical application within and across countries, and to showcase concrete examples of national implementation, such as the good practices presented at the special session. It stated that a possible e-learning course could be developed to supplement the guide. At its forty-seventh meeting, the Working Group reconfirmed the need for and added value of such a guide and agreed that members should actively explore funding opportunities for this and report back at the next meeting.

The Working Group will be invited to discuss the development of the guide (or portions of it) and a related timeline, given the Netherlands has pledged to provide partial funding for this activity.
