Dear sir,

Following your petition addressed to the Association of Intercommunity Development "Integrated Management of Waste in the Dâmbovita County" and registered with no. 10569/28.09.2023, according to the provisions of the Law no. 544/2001 on free access to information of public interest, we communicate the following:

1. Information requested regarding "NUMBER and the value PAYMENT (customized) performed by A.D. I. Integrated Management of Waste in Dambovita County to Eurogas Prescom SRL for the activity of storing non-hazardous waste at the waste depot Titu in period 01.04.2020-31.08.2023", It is exempted from communication, to respect the principle of confidentiality, a principle established between the parties, according to the provisions of clause 32., and according to clause 32.3 from contract no. 492/538/2010, concluded between the Association and SC Eurogas Prescom SRL Fieni, it was established that: "the obligations provided for in clause 32 will remain valid to termination or termination The contract and further for an indefinite period of time, .."

2. Association of Development Intercommunity " Integrated Management of Waste in Dambovita County " according to CONTRACT no. 35/728/236/16.08.2023, concluded with the SC Supercom SA Association (leader) & SC Expert Recycling SRL (associate), carried out the REQUIRED procedures in order to obtain/transfer the environmental and water management authorizations for the deposit of waste Titu. They are issued under special conditions imposed on the holder of the activity, in this case, operator Association SC Supercom SA (leader) & SC Expert Cycle Eng SRL (associate) which has the obligation to obtain these authorizations.
