
The Water Convention: supporting transboundary cooperation

Parties to the Convention (52) – newest: The Gambia, Panama, Namibia, Nigeria and Iraq (2023)


Countries very close to accession: Côte d'Ivoire, Sierra Leone, Zambia

Global Network of basins working on climate change adaptation



Objectives of the workshop

- The workshop will bring together water, agriculture, climate and environment communities as well as drought experts to jointly discuss best practices and lessons learned in addressing droughts in transboundary basins.
- Topics to be addressed:
 - drought management planning in transboundary basins, integration of drought management into river basin management planning and national actions;
 - role and activities of transboundary basins organisations; how to consider drought and water scarcity in transboundary water cooperation agreements;
 - global and regional initiatives and policies on drought management under changing climate;
 - role of aquifers;
 - early warning, data exchange and monitoring of droughts in transboundary basins;
 - flood-drought interaction in the same shared basins incl. forecasting, assessment, planning and implementation of measures;
 - Measures such as land-use management and nature-based solutions; water allocation, green and grey infrastructure solutions for droughts etc.


