- Organized special events and high-level dialogues on the topics of building resilient energy systems, critical raw materials, climate finance, energy connectivity and digitalization of energy systems.
- Delivered 3rd Almaty Energy Forum based on the strategic partnership of UN Agencies (UNECE, UNESCAP and UNDP) to help countries design and build resilient energy systems, and accelerate energy transition in Central Asia.


