Background – why we developed online training

- In Finland most of the professionals' degree programs do not include domestic violence or violence in close relationships or violence against women topics in the curriculums.
- Research shows the need of the training
- Also **Istanbul Convention** requires training the relevant professionals (article 15) on domestic violence and violence against women.
- Tool for organizations as well as for the individuals
- Launched 02/2019 in Finnish (published in Swedish at the end of the June 2021)



Target group and online platform

- Designed especially for professional development of the social and health care professionals & students and police (on-the-job training)
- Used also for example by:
 - New workers in the shelters for the victims of domestic violence
 - Daycare, Schools, Crisis centre
- Website thl.fi/Verkkokoulut
- 3600 / year has printed certificate last year -
- Platform: Moodle, training is free to use, account required, certificate can be printed



Content of the training




- Text, different type of videos, audio files, tests, group talks/tasks
- Length of time approximately
 - Groups: 8-10 hours (recommended)
 - Individuals: 6-8 hours
- Feedback is collected through the platform or via email
- Sensitive topics, different ways to understand the phenomenon = co-operation and discussions between different organisations is important



 - e.g. screening forms, assessment tools, safety plan form, marac forms...


