Dear Fiona

I am writing on behalf of the communicant in the case ACCC/C/2018/158.

We are concerned with the lack of response to the Committee's questions from the Party concerned.

The questions were sent to both the communicant and the party concerned on 19 February 2024 with the deadline for providing answers by 18 March. At the request by the Party concerned this deadline has been extended by 5 April and on that day they informed the Committee that 'few more days' are needed to finalize the answers. Now, after two more weeks, the Party concerned still has not submitted any answers.

Therefore, we would like to ask the Committee to consider setting a final deadline after which the letter from the Party concerned will not be taken into account. Otherwise, the Party concerned may prolong the procedure indefinitely.

We would like to prevent any further delays as much as possible, in particular that the case was initiated six years ago (and in June there will be 2 years since the hearing).
