## SESSION 1: NEW DEVELOPMENTS IN NATIONAL STATISTICAL LEGISLATION

#### YOLANDA GOMEZ, INE SPAIN (SESSION CHAIR)

Yolanda Gómez has a Degree in Law, a Master in European Law, a PHD studies Certificate in International Law and a Degree in Art History. Ms Gómez works as Legal Advisor at INE since the year 1999. She is an expert in legal statistical issues such as Statistical laws and Statistical principles, ethics, Code of Practices, privacy and confidentiality or Data Science and statistics, dealing with the preparation of high level international meetings and providing support and advice to the Board members on different national and international legal issues. She is also member of different international statistical groups of UN and EU and has several publications on legal statistical issues.

#### LILIIA HINCHUK, STATE STATISTICS SERVICE OF UKRAINE

Liliia Hinchuk is the Head of Directorate for Legal Support, State Statistics Service of Ukraine since 2019, responsible for the assurance of proper use of the law on official statistics.

## SESSION 2: LEGAL CHALLENGES IN OFFICIAL STATISTICS – DATA ACCESS, SHARING, PRIVACY AND TECHNOLOGY

### RICHARD RAGNARSON, STATISTICS NORWAY (SESSION CHAIR)



Richard Ragnarsøn is Head of International Secretariat in Statistics Norway, and he is responsible for international as well as national coordination of official statistics.

He started his career in Statistics Norway in 1993 working with business statistics, and he was deputy head of division until he joined Eurostat in 2001 as a seconded national expert followed by a period as deputy head of the EFTA Statistical Office in Luxembourg until 2009.

He holds a degree in economics from the University of Oslo.

#### DAGMARA KOSKA, EUROSTAT

Dr Dagmara Koska is Head of Unit responsible for Eurostat's legal affairs, planning & evaluation activities as well as document management. Between 2018 and 2023, she worked as a diplomat for the European External Action Service. She was posted at the EU Delegation to the USA in Washington D.C., where she deputized for the Head of Global Issues and Innovation Section comprising climate, energy, environment, maritime affairs, transport, research & innovation and health policies. She oversaw climate and energy policies and managed EU relations with the U.S. Administration, the U.S. Congress, the U.S. States and municipalities, non-governmental organisations, academia and industry.

Before joining the European Commission in 2008, Dagmara worked in law firms Cleary Gottlieb Steen & Hamilton LLP in Cologne and Redeker Sellner Dahs in Bonn, Germany, advising clients on German and International competition and corporate law.

### PETER STRUIJS, EUROSTAT

Peter Struijs is statistical officer for big data and trusted smart statistics at Eurostat, where he has contributed to the revision of the framework regulation on European statistics, in particular by supporting the High-Level Expert Group on facilitating the use of new data sources for official statistics and in drafting the Impact Assessment for that revision. Peter was previously employed by Statistics Netherlands, where he was the coordinator of the ESSnet Big Data, a research programme in which 28 partners of the European Statistical System (ESS) jointly investigated the possibilities for the ESS to use big data for official statistics. Before big data became prominent, Peter was Head of Unit for process development and quality management at Statistics Netherlands. He is an elected member of the International Statistical Institute.

### JELENA ŽIVKOVIĆ, STATISTICAL OFFICE OF THE REPUBLIC OF SERBIA

#### BARBARA JAROSIŃSKA, STATISTICS POLAND (SESSION CHAIR)

Due to her legal education background Barbara's journey with Statistics Poland started with purely legal tasks (she had worked in the legal division). Then, she moved to the International Relations and Statistical Cooperation Department in which she currently holds the position of Deputy Director. In her capacities she coordinates cooperation with the EU institutions with the focus on the legislative process. In this respect she is also a Polish representative in the EU Council Working Party on Statistics.

### AIKATERINI KATSOURAKI, HELLENIC STATISTICAL AUTHORITY



Aikaterini Katsouraki is a Legal Associate at President's Office.

Drawing on her expertise in data, intellectual property and EU law, Aikaterini joined the Hellenic Statistical Authority as a legal advisor for strategic issues of EU and international statistical cooperation in 2020. Before, she worked in the European Union Intellectual Property Office, the European Patent Office and in a life sciences law firm. #### BARTELD BRAAKSMA, STATISTICS NETHERLANDS

In this role he has initiated and supported a wide range of innovation tracks, often in the form of concrete pilots or proofs of concept. Examples include piloting of machine-readable open data, the first infographics published by CBS, the introduction of a process mining tool for internal purposes, concrete big data experiments and pilots involving the use of mobile devices and sensors. In many cases, these innovation tracks have been realised in close collaboration with partners like cities, universities, large companies and small start-ups.



In the past, Barteld has been involved in a broad range of activities at CBS, including research and development of new statistics, quality management and enterprise architecture. Beside his CBS duties, Barteld is active in different national and international groups; for example as chair of the UN/ECE Blue Skies Thinking Network and as a member of the TAILOR network for trustworthy AI. He is also involved in the recently launched Innovation Network for the European Statistical System. Barteld was trained as a mathematician, in particular in nonlinear dynamics and chaos theory. Before and during his career at CBS he taught mathematics at universities in Holland and Belgium. In his free time, Barteld likes to play bridge; which implies a form of data processing which neither concerns open data nor big data.

#### STEPH TURNER, UNITED KINGDOM STATISTICS AUTHORITY

Steph has worked in the Legal Team at the UK Statistics Authority for ten years.
