

Delegations are encouraged to refer to the *Consolidated UN/CEFACT Mandate and Terms of Reference* (ECE/TRADE/C/CEFACT/2017/15) adopted at the twenty-third Plenary, and particularly to section D on the role and responsibilities of the Bureau and its Chair and section E on the election procedures.

A. High-level substantive segment – Policy dialogue

Item 3. Policy dialogue on the role of climate-smart connectivity and digital trade and transport corridors in support of regional and global integration and sustainable development

In recent years, the topic of climate-smart connectivity has become increasingly relevant for United Nations Member States. This includes ECE programme countries. For example, amidst the twenty-first century crises disrupting supply chains and escalating logistics costs, the United Nations Special Programme for the Economies of Central Asia (SPECA) participating States adopted the Roadmap for the Digitalization of Multimodal Data and Document Exchange Along the Trans-Caspian Transport Corridor, Using United Nations Legal Instruments and Standards³ at the 2023 SPECA Summit. This roadmap leverages United Nations legal instruments and standards, including the Customs Convention on the International Transport of Goods under Cover of TIR Carnets (TIR Convention), the Convention on the Contract for the International Carriage of Goods by Roads (CMR Convention) and the UN/CEFACT Package of Standards. The shift towards the digital exchange of data and documents can improve efficiency, reduce costs, enhance transparency, enable better accessibility and data analysis, and in so doing, it has the potential to foster greener and more inclusive economies.

Building on recent developments in the ECE region and beyond, this policy dialogue will bring together policymakers, private sector representatives and the international community to explore the potential of the digital transition for regional and global connectivity. It will reflect on the role of international, regional and national initiatives, as well as ECE legal instruments and UN/CEFACT standards to enhance facilitation procedures along trade and transport corridors while also helping address the pressing need to reduce carbon emissions. Key takeaways of this policy dialogue will contribute to the discussions at the 2024 United Nations Climate Change Conference (UNFCCC COP 29), which will take place from 11 to 22 November 2024 in Baku, Azerbaijan.

The Roadmap pursues the following vision statement for the region, with global relevance: "From 2027 onwards, economic operators and all competent authorities in the SPECA participating States will start to use electronic freight transport data from economic operators in line with relevant United Nations legal instruments and standards, including the UN/CEFACT package of standards. Data will be interoperable between sectors and the relevant modes of transport along the Trans-Caspian transport corridor, with a view to increasing the efficiency of data exchange and the movement of goods across borders". The discussion will be informed by findings and recommendations emerging from the 2023 edition of the UN Global Survey on Digital and Sustainable Trade Facilitation as well as the ECE and SPECA regional reports on digital and sustainable trade facilitation.

The ECE secretariat will report on *Matters Arising Since the Twenty-Ninth Plenary* and the activities of the ECE Economic Cooperation and Trade Division Regional Adviser. These documents provide a summary of UN/CEFACT activities in the period of 2023-2024, including normative work, policy advice and capacity-building.

C. Substantive segment – Technical dialogue and deliverables

The sixty-ninth and seventieth Commission sessions focused on the topics of "Promoting circular economy and sustainable use of resources" and "Digital and green transformations for sustainable development" in the ECE region and beyond. Member States invited subsidiary bodies to replicate and scale up existing approaches that facilitate broad and effective use of the appropriate instruments, including through capacity-building and knowledge-sharing activities.

This segment will include a technical dialogue on fostering sustainable and resilient value chains, which will provide updates on deliverables in support of the ECE strategic priorities. In this connection, UN/CEFACT has made progress on several initiatives, including (i) a draft policy recommendation on transparency at scale in value chains, outlining solutions for digital product passports; and (ii) a study on trade of second-hand clothing, providing global and regional perspectives, with a focus on the European and Latin American regions.

The segment will also feature an update from the UN/CEFACT Bureau and Regional Rapporteurs, and an overview of the reports from the Chairs of the Team of Specialists (ToS)

on Environmental, Social and Governance (ESG) Traceability of Sustainable Value Chains in the Circular Economy and the United Nations Code for Trade and Transport Locations (UN/LOCODE) Advisory Group.

The Plenary will have before it the *Draft Recommendation No.49: Transparency at Scale*, for discussion. This recommendation is undergoing a public review from 19 April until 19 June 2024 and the project team will share highlights from the feedback received during the consultation process as well as outline the next steps towards finalization of the document. The recommendation will be slated for adoption at the thirty-first Plenary in 2025.

Furthermore, the secretariat will present a short note outlining the key recommendations from the policy guidance on the implementation of traceability and transparency at scale through digital tools such as digital product passports and verifiable credentials. It will also share progress on the development of the implementation guidance material. These solutions will include the *United Nations Transparency Protocol (UNTP)*, which will be designed to ensure interoperability, and the *United Nations Digital Product Passport (UN DPP)*, which will be designed to meet disclosure requirements and to carry conformity credentials, sustainability information and other data about goods exchanged in value chain transactions.
