Review of the Bureau and Regional Rapporteurs' activities since the twenty-ninth Plenary

United Nations Centre for Trade Facilitation and Electronic Business Bureau Report of Developments

Submitted by the Bureau

Summary

This report of developments will provide an update on the United Nations Centre for Trade Facilitation and Electronic Business (UN/CEFACT) Bureau activities since the twenty-ninth Plenary, held on 9 and 10 November 2023. The report provides a concise overview of the developments in each programme development area, followed by three annexes outlining a list of all UN/CEFACT Bureau decisions since the last Plenary. It also includes a list of all conferences where the Bureau and secretariat were officially represented, as reported in regular UN/CEFACT Bureau calls, and a list of all projects which were active during this reporting period.

Document ECE/TRADE/C/CEFACT/2024/4 is submitted to the thirtieth session of the UN/CEFACT Plenary for information.



I. United Nations Centre for Trade Facilitation and Electronic Business Bureau reporting on the years 2023-2024

1. Since the twenty-ninth Plenary, held on 9 and 10 November 2023, the UN/CEFACT Bureau has held six regular Bureau calls, during which project development and procedural points were discussed. These activities represent the reporting period from 1 September 2023 to 30 April 2024. As per the Consolidated UN/CEFACT Mandate and Terms of Reference (ECE/TRADE/C/CEFACT/2017/15) article 49, a list of all Bureau decisions has been provided in Annex I. There were 36 Bureau decisions taken during this period.

2. The structure of the Bureau was updated following the election of the Bureau Vice Chairs at the twenty-ninth UN/CEFACT Plenary, as per Plenary decision 23-02 in the Report of UN/CEFACT on its twenty-ninth session (ECE/TRADE/C/CEFACT/2023/2). The six current Bureau Vice Chairs are as follows:

- Mr. Steve Capell of Australia, UN/CEFACT Vice Chair (private sector);
- Mr. Aliakbar Heydarov of Azerbaijan, UN/CEFACT Vice Chair (public sector);
- Ms. Nancy Norris of Canada, UN/CEFACT Vice Chair (public sector);
- Ms. Hanane Becha of France, UN/CEFACT Vice Chair (private sector);
- Ms. Liliana Fratini Passi of Italy, UN/CEFACT Vice Chair (private sector); and

3. Two new Regional Rapporteurs for the regions of Africa and Latin America were also elected at the twenty-ninth UN/CEFACT Plenary and one Regional Rapporteur for Asia and the Pacific was re-elected, as per Plenary decision 23-03 in the Report of the UN/CEFACT on its twenty-ninth session (ECE/TRADE/C/CEFACT/2023/2). The three current Regional Rapporteurs are as follows:

- Ms. Nogaye Toure Diagne, UN/CEFACT Regional Rapporteur for Africa;
- Mr. Hisanao Sugamata, UN/CEFACT Regional Rapporteur for Asia and the Pacific; and
- Mr. Eduardo Leite, UN/CEFACT Regional Rapporteur for Latin America.

4. Ms. Kseniya Shychko was appointed as a new focal point for both the JSON-LD Vocabulary and the Code List by Bureau decision 2402015 in February 2024. The current domain coordinators and focal points are as follows:

5. The Bureau and secretariat strive to keep track of all meetings at which UN/CEFACT is officially represented. There is a conscious effort to ensure that the work is presented in a consistent manner in the interest of the organization. 48 events were recorded on regular Bureau calls. The full list is available in Annex II.

6. The Bureau and secretariat also plan to work together with the UN/CEFACT expert community in the near future on the impact assessment of the UN/CEFACT deliverables, as well as strengthening of linkages between the UN/CEFACT projects and the 2030 Agenda and Sustainable Development Goals (SDGs), including activities to:

- Develop a mapping of the UN/CEFACT projects and their alignment and contribution to the SDGs;
- Conduct impact assessment along with stakeholders and beneficiaries and collect measurable metrics for the UN/CEFACT projects; and
- Further consolidate and streamline the UN/CEFACT projects and deliverables, in order to increase engagement of broad audiences and external stakeholders.

7. A full list of all active projects between 1 September 2023 and 30 April 2024 is available in Annex III. As per the UN/CEFACT Open Development Process (ECE/TRADE/C/CEFACT/2016/17) article 24, all new projects submitted during this period are highlighted in this table.

8. As of April 2024, there were 1,618 experts registered within UN/CEFACT.

II. International Trade Procedures Programme Development Area

9. Since the last Bureau report, the International Trade Procedures (ITP) Programme Development Area (PDA) has submitted the draft Recommendation No.49: Transparency at Scale to the Bureau for approval to launch the public review.

10. Current active projects of the ITP PDA include the following:

- Business Requirement Specification for Digital Product Conformity Certificate Exchange – High Level Process;
- Data Governance for Trade Facilitation;
- Digitization of Transit Accompanying Documents – Document Requirements for Goods in Transit;
- Guidelines on Establishing a Regional Single Window;
- Recommendation for Trade Information Portals;
- Single Window Assessment Methodology; and
- Transparency at Scale: Digital Solutions for Trust, Resilience and Sustainability.

III. Sustainable International Supply Chain Programme Development Area

11. Since the last Bureau Report, as per Bureau decision 2312002 in December 2023, the newly elected Bureau approved the updated organigram of the Bureau, which included projects under the Cross-Border Management (CBM) Domain of the previous Regulatory

and eGovernment PDA being merged into the Sustainable International Supply Chain (ISC) PDA.

12. The ISC PDA has published the Business Requirement Specification (BRS) on the Product Circularity Data use case of the “Extension of BRS Traceability and Transparency in the Textile and Leather Sector, Part 2” project.

13. Current active projects of the ISC PDA include the following:

- Cross-Border Multimodal Digital Corridors for Regulatory-Related Movement of Consignment Data and Consignment Status Information for Trade Facilitation;

- UN/EDIFACT Dangerous Goods Notification message (IFTDGN) Dangerous Goods;
- International Maritime Organization (IMO) eFAL¹ Electronic Compendium Mapping;
- Parcel Goods Traceability in Last-Mile Delivery;
- Product Circularity Data: Extension of the BRS on Traceability and Transparency in the Textile and Leather Sector Part 2: Use Cases and Core Components Business Document Assembly (CCBDA) Data Structure;
- Sustainable Development and Circular Economy Reference Data Model;
- Transfer of United Nations Commission on International Trade Law (UNCITRAL) Model Law on Electronic Transferable Records (MLETR)-Compliant Titles;
- Travel Agency and Destination Managing Company API Reference Data Model; and
- Waste Management and Waste Analysis.

IV. Methodology and Technology Programme Development Area

14. As per Bureau decision 2312002 in December 2023, the newly elected Bureau approved the updated organigram of the Bureau, with projects under the eData Management (eData) Domain of the previous Regulatory and eGovernment PDA being merged into the Methodology and Technology (M+T) PDA.

15. The M+T PDA has finalized and published the semi-annual release of the UN/EDIFACT directories (D.23B), the United Nations Code for Trade and Transport Locations (UN/LOCODE) directories (2023-2), the Core Component Library (versions D.23B) as well as the corresponding XML Schema Library (versions D.23B).

16. Current active projects of the M+T PDA include the following:

- Digital Identity Standardization for Trade Facilitation;
- Linked Data Vocabulary and Shapes Project; and
- Open API generation from domain models.
