



Legislative mandate/Confidentiality assurance

The Law of Armenia "On Official Statistics" (2018), which is fully consistent with GLOS (2016)

- ensures strict protection of data confidentiality

Chapter 7 on Statistical Confidentiality (5 Articles)








Challenges

- Massive information flows/ flood of data






Ways to harmonize the perception of the Confidentiality principal in the rapidly growing demand for individual data


 Individual data collected for statistical purposes shall not have probative force by law, in order to reduce the temptation for users to access such data.

"Individual data collected for statistical purposes should not be used by anybody or international organization to make investigative, judicial, administrative decisions or in other similar processes relating to natural or legal persons." (Article 23, Part 3).




Stimulating the development of alternative sources of individual data

It is necessary to promote the implementation of the **Digital Integrated Administrative Registers System**, which will mitigate the temptation of state and municipal bodies to request individual data from official statistics. This system is based on the Nordic model and is built on a single identification code, the same definitions and classifications.








Data stewardship

- One of the new directions in the development of official statistics is Data stewardship, which also has a certain potential to mitigate the above temptation.
- Empowering the producer of official statistics with data stewardship will contribute to improving the data quality of the bodies and organizations that generate the databases and ultimately creating a demand for quality individual data from these sources, which in turn will reduce the need to access such data from official statistics.




Organizations providing quasi-fiscal data, agencies implementing programs, private and public non-governmental organizations maintaining registers in the context of Big Data






Armstat role in data stewardship (administrative registers)




