NOTICE OF INITIATION OF PROCEEDINGS

Pursuant to and for the purposes of the following articles of law:

- Articles 16 and 12 of the Consolidated Text DPR 327/2001 and ss.mm.ii;
- ArL 7 et seq. of Law 241/90 et seq.
- D. Lgs 50/2016 e ss.mm.ii.

The Extraordinary Commissioner appointed by the DPGM of 16 April 2021, pursuant to Article 4 of the Decree Law

18 April 2019 no. 32 'Urgent provisions for the revitalisation of the public contracts sector, for the acceleration of infrastructural interventions, urban regeneration and reconstruction following seismic events' (so-called 'unblocking worksites' decree), in the text in force following the amendments made by Decree-Law no. 76 of 16.07.2020, effective from 17.07.2020 and by the Conversion Act, Law no. 11.09.2020,

No. 120 with effect from 15.09.2020;

- Considering that the intervention in question is included among those listed in Annex 1 of the Prime Ministerial Decree of 16 April 2021;
- Considering that Article 4, paragraph 5 of Decree-Law no. 32/2019 and Article 2, paragraph 2 of the Prime Ministerial Decree of 16 April 2021 envisage that the Extraordinary Commissioner shall avail himself of the structures of Anas for the performance of his duties;
- ANAS S.p.A. was identified as the expropriating company for the areas required for the two-lane upgrading of the Guinza Tunnel section (Lot 2) and the Guinza - Mercatello Ovest section (Lot 3) of the E78 Grosseto - Fano international route.

the commencement of proceedings for the 'approval of the final project' and 'the declaration of public utility' relating to the areas affected by the works in question.

The final project covers the municipalities of Mercatello sul Metauro (PU) and San Giustino (PG).

Pursuant to paragraph 3, art. 3 of Presidential Decree 327/2001 (Testo Unico Espropri), if the cadastral owners are no longer the owners of the real estate property concerned by the procedure in parodia, they are required to communicate this within 30 (thirty) days from the date of communication of this notice, also indicating, if they are aware of it, the new owner, and in any case providing copies of the deeds in their possession useful to reconstruct the legal ownership of such real estate.
