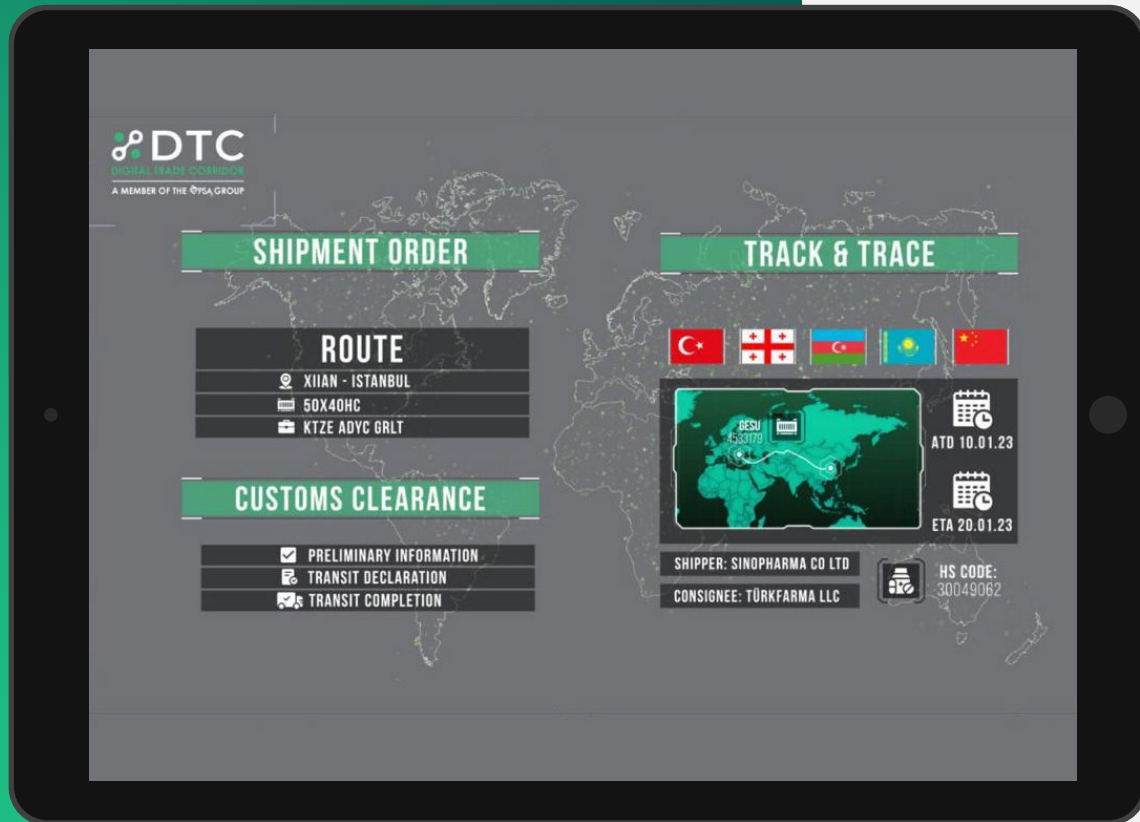

В Казахстане автоматизировали процесс оформления таможенных деклараций для транзитных грузов на казахстанско-китайской границе. Нынешней зимой был запущен пилотный проект по внедрению новой цифровой платформы Tez Customs. Он позволяет автоматически подавать и выпускать транзитные таможенные декларации для грузов, перемещаемых по железной дороге по маршрутам из Китая в Центральную Азию и Европу.

Проект осуществляется совместными усилиями Комитета госдоходов Минфина РК (КГД), АО НК «Казахстан темір жолы» (КТЖ) и сингапурской компании Global DTC - дочерней организации ведущего мирового портового оператора PSA International. Данное решение меняет существовавший ранее подход, обеспечивает прозрачность, способствует ускорению и упрощению таможенных процедур. Этот важный шаг приближает Казахстан к усилению позиций в качестве транзитного хаба в Евразии.

Платформа Tez Customs обеспечивает автоматизацию процесса безбумажного оформления таможенного транзита. Этот процесс включает подготовку предварительной информации, автоматическую регистрацию и выпуск транзитных деклараций. При этом информационная система

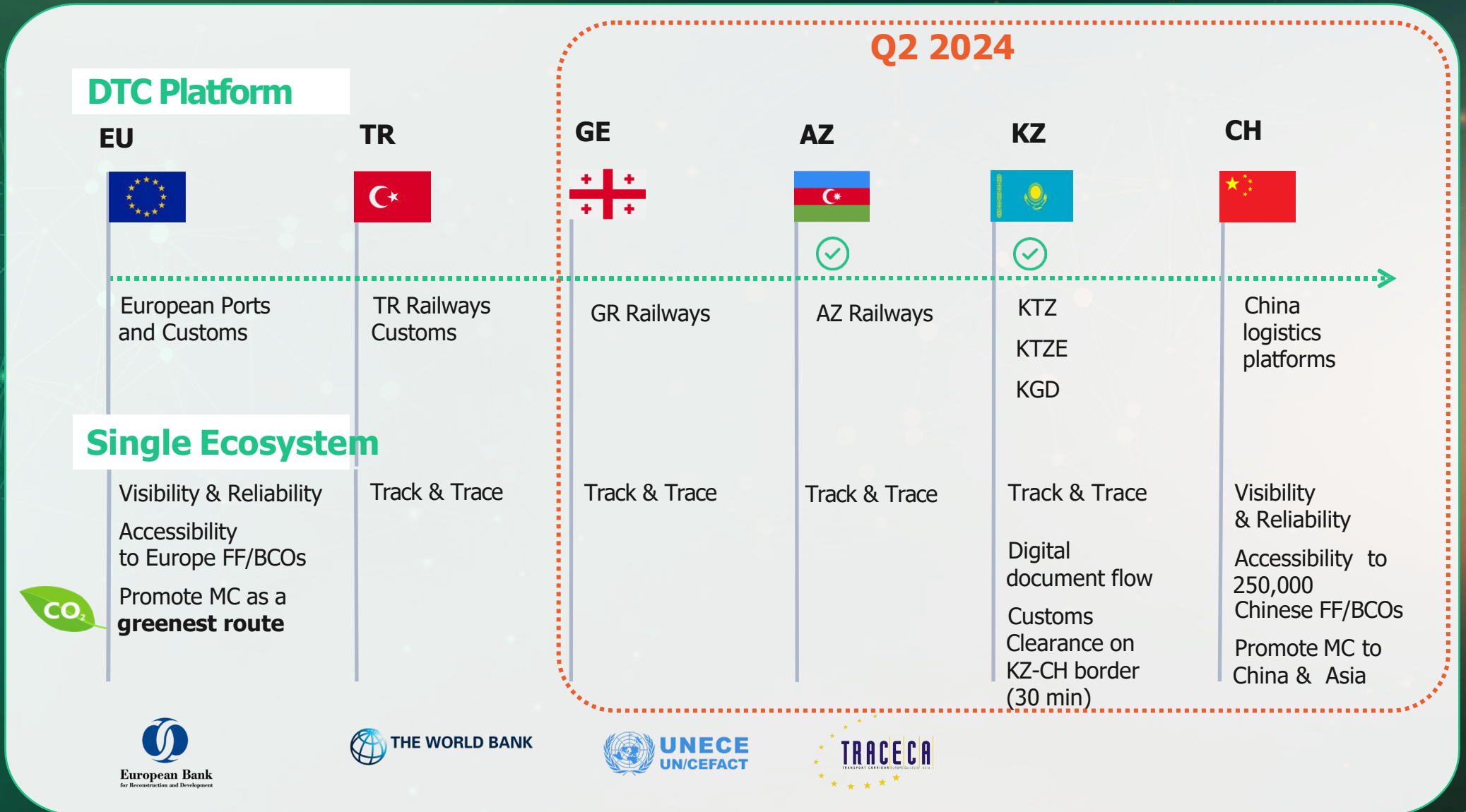
