The <u>Trees in Dry Cities Coalition</u>, under the auspices of UNECE's <u>Trees in Cities Challenge</u> and its <u>Tree Policy Action Lab</u> (Tree PAL), emphasizes the significance of urban trees and nature in dry climates. A draft Action Agenda was developed based on the outcomes of the **First Meeting of the Coalition**, held with organizations that participating in the COP28 event, drawing upon the insights provided by Focal Points from these organizations. The **Second Meeting of the Coalition** served to review the draft Action Agenda and identify key priorities and actionable steps to include in an implementation plan. This plan will be presented at the **Third Meeting**, which invites stakeholders to join the coalition and collaborate in activities of interest.
