# Working Party on Agricultural Quality Standards (WP.7)

## Organization:

- Working Party + 4 Specialized Sections
- 5 annual intergovernmental meetings
- Open to all UN member States
- Serviced by the Economic Cooperation and Trade Division (ECTD)

## Over 100 commercial quality standards:

- Fresh fruit and vegetables, nuts and dried fruit, seed potatoes, meat, eggs
- Open development and adoption process, regular revisions, inputs from parties
- Complemented with guidance materials, illustrative posters and leaflets, code mark registry, etc.



## Quality helps:

- Increase benefits from international trade
- Prevent food loss

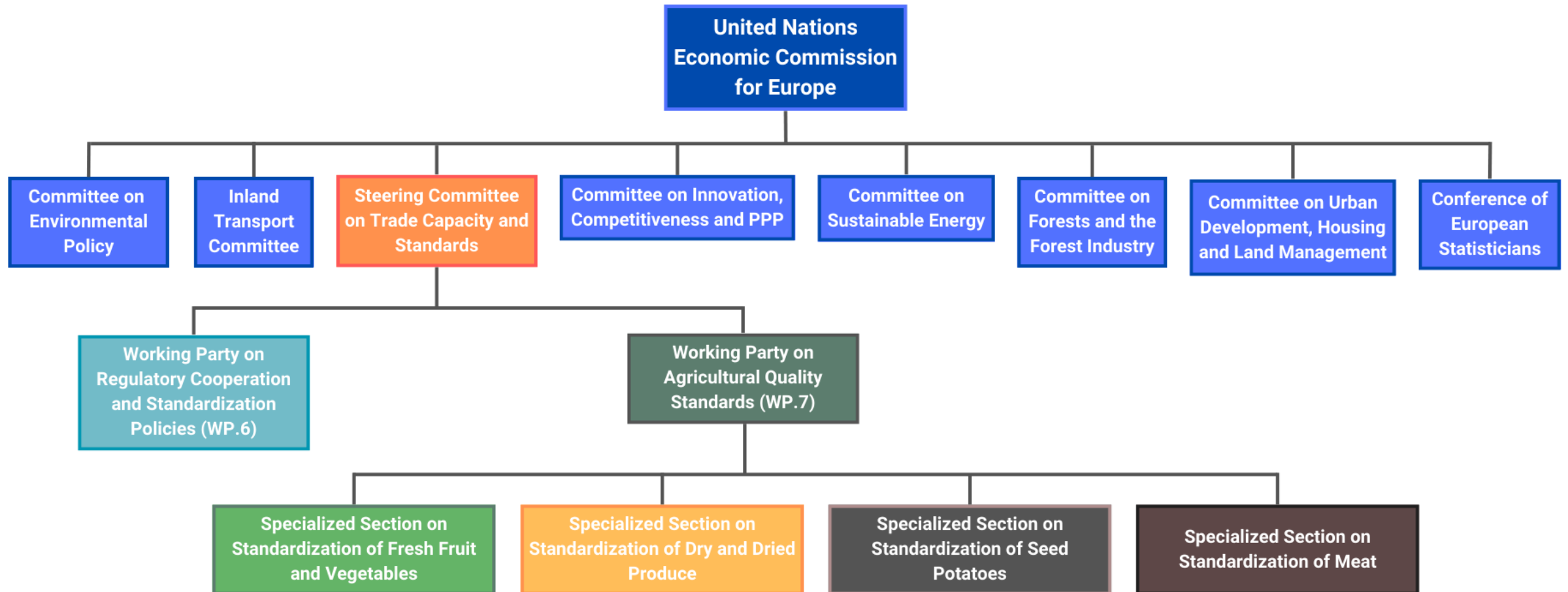

# OIOS evaluation of ECE work on Economic Cooperation and Trade

## Background and objective

- In 2022, the Office of Internal Oversight Services (OIOS) conducted a regular evaluation of subprogrammes 4 (Economic cooperation and integration) and 6 (Trade)
- Report published in March 2023 ([E/AC.51/2023/5](#))

## Findings

- Relevance:
  - The work of ECTD was considered aligned with its mandate.
  - The Division largely responded to specific member States' requests and had “found its niche in a crowded space of trade and economic cooperation”.
- Effectiveness.
  - The Division's work on facilitating norms and standards setting was largely effective.
  - There were numerous instances of norms and standards being adopted into national policies and legislation”, such as in the case of fresh fruit and vegetables standards in the European Union.

## Recommendations

ECTD should establish a technical cooperation request tracking mechanism; develop divisional action plans to operationalize ECE strategies on resource mobilization, partnerships, and technical cooperation; and ensure integration of gender, environment, disability inclusion, and human rights considerations in its various workstreams.

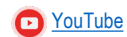
