Einleitung

- 1. Auf der dreiundvierzigsten Sitzung des ADN-Sicherheitsausschusses wurden die empfohlenen ADN-Klassifikationsgesellschaften gebeten, die Einhaltung der Anforderungen des Unterabschnitts 1.15.3.8 nachzuweisen. Diese Bitte ist im Sitzungsprotokoll in Absatz 23 wiedergegeben.
- 2. Mit dem vorliegenden Dokument informiert Lloyd's Register den ADN-Sicherheitsausschuss über die Einhaltung dieser Anforderungen.
- 3. In der Anlage ist das Zertifikat von Lloyd's Register Group Ltd (LR) nach ISO 9001 beigefügt. Der Geltungsbereich umfasst: "Die Erbringung der technischen Dienstleistungen der Klassifizierung von Schiffen, beweglichen Offshore-Anlagen und Hilfssystemen, sowohl für den Neubau als auch für in Betrieb befindliche Schiffe, in Übereinstimmung mit den Anforderungen der Regelung für Qualitätsmanagementsysteme (QMSR). Die Durchführung hoheitlicher Aufgaben im Auftrag der benennenden Behörden eines Flaggenstaats.".
- 4. Das Britische Normungsinstitut (BSI) ist die von LR ausgewählte Zertifizierungsstelle, die von UKAS (United Kingdom Accreditation Service nationale Akkreditierungsstelle) akkreditiert ist.
- 5. Der Internationale Verband der Klassifikationsgesellschaften (International Association of Classification Societies, IACS) stellt jedes Jahr eine Konformitätserklärung (Statement of Compliance, SoC) aus, die die Konformität von LR mit dem IACS-Programm zur Zertifizierung von Qualitätssicherungssystemen bestätigt.

- 6. Dieses Programm und seine Anforderungen beruhen auf dem RO-Code, der ISO 9001 und der ISO 17020 sowie den spezifischen IACS-Anforderungen. Die Konformitätserklärung bestätigt, dass LR die IACS QSCS-Anforderungen und damit die Anforderungen der ISO 17020 erfüllt, basierend auf dem Auditprogramm, das BSI jährlich durchführt. Dieses Dokument ist ebenfalls beigefügt.
- 7. Die obigen Ausführungen belegen, dass LR ein wirksames Qualitätsmanagementsystem, das sich auf geeignete Teile international anerkannter Qualitätssicherungsnormen stützt und mit den Normen EN ISO/IEC 17020:2012 und ISO 9001 in Einklang steht, umgesetzt hat und dieses aufrecht erhält.
- 8. Zudem geht aus dem Vorstehenden hervor, dass das System von LR von unabhängigen Überprüfern zertifiziert ist, die durch die Verwaltung des Staates anerkannt sind, in dem sie ihren Sitz haben.
- 9. Im Rahmen des Managementsystems von LR gibt es definierte Anforderungen für die Binnenschifffahrt, die den Anforderungen für die Seeschifffahrt (soweit anwendbar) gleichwertig sind, z. B. binnenschifffahrtsspezifische Vorschriften, Besichtigungsverfahren, Fachkompetenzen usw.
