### Key trends in the ECE region



Implementation rates of trade facilitation measures, by country group, ECE, 2021 and 2023 (%)



# IMO FAL Compendium

- A new partnership between IMO, the World Customs Organization, UNECE and the International Standards Organization has been signed to support this increased maritime digitalization.
- Since 2016, the IMO has been working to integrate electronic document concepts into the convention, collaborating with UN/CEFACT, WCO, and ISO.
- UNECE has been cooperating to develop the IMO Reference Data Model, which is a key element of the IMO Compendium on Facilitation and Electronic Business.
  - Actively participates in the IMO Expert Group on Data Harmonization (EGDH) set up by the Facilitation Committee, which is responsible for the technical maintenance and extension of the IMO Compendium.



# World Customs Organization

- The WCO Data Model is designed to provide a complete set of data and data structures for Customs and related agencies, such as agriculture and environmental protection. The model can be used to develop messages incorporating export, import and transit operations particularly with regard to a [Single Window](#) project.
- UN/CEFACT Experts are regular contributors to the work of the **WCO Customs data modelling project team (DMPT)**
  - Maintains an active Liaison relation with WCO Data Modelling Project Team.
  - Specific contributions include alignment with standards-based **supply chain (Buy-Ship-Pay) B2B data modelling** thereby maximising data structure alignment between the trade and government sides of a Single Window.
- The **MoU Management Group (MoU/MG) on 12-13 December 2023** in Geneva, the participating organizations took note of standards that are developed under the World Customs Organization (WCO) Data Model and discussed the alignment with the UN/CCL and RDMs.
  - UNECE CEFACt and WCO are working to fully harmonize their data models.
- The WCO, with the UNECE, ISO and other international standards development and trade related organizations will be collaborating on the joint [UNTDED/ISO 7372 Update Project](#).

**Check-IBAN Open finance use case** (approved by the Bureau in July 2023)

### Scope:

The purpose of this project is to develop an information exchange standard for the Check IBAN open finance use case, to enhance cybersecurity and fraud detection measures within electronic business and international trade by immediately verifying the correct association between a given IBAN code and a certain Tax Code/VAT number.

### Deliverables:

- Business Requirement Specification
- Optional: NDR (Naming and Design Rules); RSM (Requirements Specification Mapping)

### Forum outcomes and next steps:

- The Finance & Payment domain discussed and approved the draft of the Business Requirement Specification of the Check-IBAN service
- The BRS will be now submitted to the UN/CEFACT Bureau for discussion and approval to go for public review
- During the next UN/CEFACT Forum, and according to the state of BRS approval procedure, the Finance & Payment domain will discuss whether moving forward to NDR (Naming and Design Rules) and RSM (Requirements Specification Mapping) of the Check-IBAN service.

## CURRENT PROJECTS:

### **Accounting & Audit Reference Data Model**

#### *Scope:*

This project will make it faster and easier to share tax, audit and accounting data seamlessly and reliably across different accounting systems, accounting standards and jurisdictions.

#### *Current status:*

- A proof of concept (POC) is in progress to validate a VAT/sales tax use case
- The POC demonstrates that VAT/sales tax data can be expressed in two standards (XBRL-GL and SAF-T)

#### *Next steps:*

- Collaborate with the EU Tax Observatory on a global minimum tax use case. Project deliverables fit with the missions of the EU Tax Observatory.
- Seek support from accounting bodies, associations and stakeholders to implement the deliverables
- Seek new experts
- Map and migrate mappings into GEFEG

## REVIEW OF THE BUREAU AND REGIONAL RAPPORTEURS' ACTIVITIES SINCE THE TWENTY-NINTH PLENARY

### Proposed Plenary decision:

### **Plenary decision 24-07 to be noted:**

- The Plenary took note of the UN/CEFACT Bureau Report of Developments (**ECE/TRADE/C/CEFACT/2024/4**) and the UN/CEFACT Report of the United Nations Centre for Trade Facilitation and Electronic Business Regional Rapporteurs (**ECE/TRADE/C/CEFACT/2024/5**).
- The Plenary requested that the Bureau and the Regional Rapporteurs present a consolidated report on activities and flagship projects, focusing on impact and relevance, at the next Plenary in 2025.

### **Plenary decision 24-08 to be noted:**

- The Plenary took note of the white papers, business requirements specifications, publications and the data exchange standards presented by the UN/CEFACT Bureau and requested that they continue to be updated on a regular basis, emphasizing the importance of maintaining such standards and promoting their uptake at the global, regional and national levels. The Plenary appreciated the ICC DSU-UNECE joint call to action launched at the 42nd UN/CEFACT Forum, and invited policy makers and industry representatives to express their commitment to adopting digital standards. The Plenary requested the secretariat to report again in 2025 session and make an extra effort to seek for extrabudgetary funding for relevant activities.
- The Plenary emphasized the relevance of these activities to enhancing digital and green connectivity and highlighted their importance for capacity-building.
