

Self-evaluation on the relevance of the Forest Products Annual Market Review to the needs of member States and challenges in the forest sector

1	The evaluation recommends the Forest Products Annual Market Review to include information, data and statistics on Sustainable Development Goals relevant to the various forest products market sectors.	UNECE accepts the recommendation. One of the core objectives of the publication is to inform the audience about the situation of production and consumption of forest products markets and their contribution to accelerate progress towards the achievements of the Sustainable Development Goals (SDGs). The first chapter of the publication on Economic Overview and Policies lends itself to be a good place to include information, data and statistics on the SDGs relevant to the various forest products market sectors. The Joint UNECE/FAO Forestry and Timber Section (the Joint Section) will focus mainly on highlighting the information for SDGs 7 and 12.	Forests, Land Management and Housing Division (FLHD)	31 December 2023	Implemented The Forest Products Annual Market Review was published in November 2023 and includes information, data and statistics on Sustainable Development Goals relevant to the various forest products market sectors. The link to the SDG's is clearly stated in the introduction (page 2): "The analysis of the various wood commodity markets now also contains additional information on how these market trends contribute to the achievement of the various United Nations Sustainable Development Goals (SDGs), namely SDG 7 ("Ensure access to affordable, reliable, sustainable and modern energy for all"), 11 ("Make cities and human settlements inclusive, safe, resilient and sustainable"), 12 ("Ensure sustainable consumption and production patterns"), 13 ("Take urgent action to combat climate change and its impacts") and 15 ("Protect, restore and promote sustainable use of terrestrial ecosystems, sustainably manage forests, combat desertification, and halt and reverse land degradation and halt biodiversity loss")." Specific references are made a various part of the specific chapters (e.g. forest certification or sawn hardwood and SDG 15.2).

The secretariat highlighted recommendation 4 and member States took note of the funding needs. The Committee on Forests and the Forest Industry took note of the report from the Joint Working Party. The secretariat did not manage to obtain any firm pledges for long term funding of the publication.
5	The evaluation recommends the subprogramme to raise to the extent possible, awareness among member State representatives and readers of the Review on gender and human rights issues related to the forest market sector. This could be done by including a relevant question on gender and human rights in the Country Market Statements, the results could be summarized in the economic overview and policies chapter of the Review.	UNECE accepts the recommendation. The Joint Section will include a relevant question on gender and human rights in the annual Country Market Statement prepared by member States. These statements are prepared for the meetings of the Committee on Forests and the Forest Industry. As the structure and main topics of the Country Market Statements are prepared by the Joint Section and requests for the country market statement will be sent in Q3 2023 to member States, the Joint Section will include in the 2023 template a request for relevant information on gender and human rights issues related to the forest market sector. The Joint Section will, in a second step, use the information provided by member States, and add a segment in the economic overview and policies chapter of the Market Review of 2024.	FLHD	31 December 2024	In progress The secretariat informed member States during the 44th session of the Joint Working Party on Forest Products Statistics, Economics and Management (31 May – 2 June 2023) about the Self-evaluation on the relevance of the Forest Products Annual Market Review to the needs of member States and challenges in the forest sector. The secretariat highlighted recommendation 5 and member States took note of the inclusion of questions on gender and human rights in the Country Market Statement. The request for the country market statements was sent to member States in June 2023 with a submission deadline of October 2023. 12 out of 18 member States included for the first time a chapter on "Gender and human rights issues related to the forest market sector" (https://unece.org/forests/2023-country-market-statements). The secretariat highlighted the availability of this information under agenda item 5 (e) of the 81st session of the UNECE Committee on Forests and the Forest Industry (https://unece.org/sites/default/files/2023-08/ECE_TIM_2023_1_FAO_EFC_2023_1_en.pdf). The 2023 edition already included a short text about the Women's Forest Congress, and it is planned that the 2024 edition of the Forest Products Annual Market Review will include a summary of the information provided by member States.
