HIGH-LEVEL POLICY DIALOGUE ON THE ROLE OF CLIMATE-SMART CONNECTIVITY AND DIGITAL TRADE AND TRANSPORT CORRIDORS IN SUPPORT OF REGIONAL AND GLOBAL INTEGRATION AND SUSTAINABLE DEVELOPMENT

In recent years, climate-smart connectivity has become increasingly relevant for United Nations Member States, including UNECE programme countries. Amid crises disrupting supply chains and escalating logistics costs, in 2023, SPECA participating States adopted the [Roadmap for the Digitalization of Multimodal Data and Document Exchange Along the Trans-Caspian Transport Corridor, Using United Nations Legal Instruments and Standards](#), aimed at improving efficiency, reducing costs, enhancing transparency, and enabling better accessibility and data analysis through leveraging UN legal instruments and standards, including the TIR Convention, the CMR Convention, and the UN/CEFACT Package of Standards. This policy dialogue will bring together policymakers, private sector representatives, and the international community to explore the potential of digital transition for regional and global connectivity. It will examine international, regional, and national initiatives, and UNECE legal instruments and UN/CEFACT standards, to enhance trade and transport corridors and address the need to reduce carbon emissions.

TECHNICAL DIALOGUE ON GLOBAL SOLUTIONS FOR DIGITAL, SUSTAINABLE AND RESILIENT VALUE CHAINS IN SUPPORT OF THE GREEN AND DIGITAL TRANSFORMATIONS

Over the past two decades, demands for enhanced sustainability and transparency in corporate reporting have intensified, impacting consumer preferences, business norms, capital access, and regulatory measures. Emerging regulations, such as the EU directives on due diligence, green claims, and deforestation, now carry significant consequences. Credible evidence and transparent value chains are essential to combat false sustainability claims, promoting higher sustainability standards. In response to these challenges, UN/CEFACT has advanced initiatives, including [Draft Recommendation No.49: Transparency at Scale](#), proposing solutions like digital product passports and verifiable credentials. This policy dialogue will discuss Recommendation No.49, feedback from the consultation process, and steps towards its finalization for the 2025 Plenary. It will also share progress on the United Nations Transparency Protocol (UNTP) and [the United Nations Digital Product Passport \(UN DPP\)](#). Additionally, the event will highlight findings from the [UNECE-ECLAC Study on Reversing Direction in the used clothing crisis: Global, European and Chilean Perspectives](#), reviewing global flows, regulations, and business models in the EU and Latin America.
