GEOSTM is located in Tbilisi, Georgia.






All GEOSTM premises comply with the requirements of standards and safety regulations.




Structural Units of GEOSTM

State Policy Measures towards Gender Equality

Over the past decades Georgia took important steps towards the implementation of policy measures to ensure Gender equality and the empowerment of women.

- in 2015, Georgia, along with all other UN member states, committed to implement all 17 sustainable development goals (SDGs) and targets, including SDG 5 (Gender Equality and Women's Empowerment).
- In 2017, Georgia declared all 17 SDGs as national priorities.



The main authority responsible for the coordination and oversight of the national agenda with regards to SDGs is the Government Administration of Georgia.

According to the Georgian National Concept on gender equality, Gender inequality and gender-based violence impede women from realizing their full potential. At the same time, gender-neutral laws, policies or practices may not always achieve equality and in some cases may be discriminatory. Therefore, the state emphasizes the need to implement a gendersensitive approach at different levels.



The actual number of GEOSTM staff comprises 65 employees (34 Female and 31 Male) in total, with the share of female employees being 52 percent.

GEOSTM acknowledges the importance of inclusiveness and diversity for the standardization system and the need for development of standards that equally beneficiate everyone regardless of their gender.

In order to contribute to this objective, in 2020 The Georgian National Agency for Standards and Metrology joined the Declaration on Gender-Responsive Standards and Standards Development, as well as elaborated National Standardization Strategy (NSS) in cooperation with ISO experts, which defines standards and standards projects based on economic and non-economic assessment of sectorial needs, including standards under all SDGs. Since signing of the Declaration on Gender-Responsive Standards and Standards Development, the following capacity building activities were conducted in GEOSTM:

- Within the framework of the ISO Action Plan for developing countries 2021-2025, two representatives of GEOSTM attended the ISO regional workshop to develop an organizational Gender Action Plan, in Tashkent, 2023.
- On May 18, two employees of the GEOSTM completed the online learning courses: "I Know Gender 1-2-3: Gender Concepts to get Started; International Frameworks for Gender Equality; and Promoting Gender Equality throughout the UN System" and received international certificates of the Training Center of the UN WOMEN.
- As a beneficiary of the Twinning Project "Strengthening of institutional as well as human capacities of Georgian National Agency for Standards and Metrology (GEOSTM) according to the international/EU best practices", the representatives of the GEOSTM visited Standards Bodies of Italy and Spain to learn from their experience, among others, on the topic of Gender.
