Prices of TIR Carnets*

Note by the secretariat

I. Background

1. Since the entry into force, on 1 January 2012, of the amendments to Annex 9, Part I of the TIR Convention, 1975, one of the obligations of national associations is to provide the TIR Executive Board (TIRExB), annually, before 1 March, with the price of each type of TIR Carnet it issues.

II. Information received

- 2. In 2012, the secretariat received information from 10 associations. In 2013, 2014, 2015, 2016, 2017, 2018, 2019, 2020, 2021 and 2022, 48, 49, 50, 51, 48, 50, 50, 41 and 37 associations, respectively, provided TIRExB with data on the prices of each type of TIR Carnet they issue.
- 3. Forty-six associations have provided TIRExB with the 2023 prices and 42 with the 2024 prices
- 4. The prices received for 2012, 2013, 2014, 2015, 2016, 2017, 2018, 2019, 2020, 2021, and 2022, converted to United States dollars (USD)¹, can be found on the TIR website². The prices received for 2023³ and 2024, converted to USD, are presented in Annex I and II, respectively.

³ Due to administrative complications with the survey tool which was used to collect the TIR carnet prices, the 2023 survey could only be finalized in 2024.

III. Analysis

A. Scope and methodology

- 5. Considering that, in 2022, the 6 and 14 volets represent the majority of TIR Carnets distributed by the international organization (see Informal document WP.30/AC.2 (2023) No. 5), the scope of this analysis is limited to those two types of TIR Carnet, issued to members/national transporters and non-members/foreign transporters (when data is available). In 2023, the 6, 14 and 16 volets represent the vast majority of TIR Carnets distributed by the international organization (see Informal document WP.30/AC.2 (2024) No. 2). However, few association have reported prices for the 16 volets TIR Carnets. Consequently, the scope of this analysis is limited to the 6 and 14 volets of TIR Carnet, issued to members/national transporters and non-members/foreign transporters (when data is available).
- 6. For countries having more than one association, a price average is used.

C. Analysis of the 2023 TIR Carnet prices

1. Prices in 2023

(a) 6 voucher TIR Carnet (Member/ National)

8. In 2023, the three countries with the most expensive prices are Sweden (180.28 USD), Switzerland (174.86 USD) and Denmark (171.35 USD). The three countries with the cheapest prices are: Turkmenistan (32.13 USD), Saudi Arabia (32.18 USD) and Poland (32.65 USD).

(b) 6 voucher TIR Carnet (Non-member/ Foreign)


Figure II 2023 prices of the 6 voucher TIR Carnet (Non-member/ Foreign)



9. In 2023, the three countries with the most expensive prices are: Switzerland (284.15 USD), Sweden (208.75 USD) and Denmark (190.39 USD). The three countries with the cheapest prices are: Turkmenistan (32.13 USD), Poland (32.65 USD) and Iran (Islamic Republic of) (35.35 USD).

10. In 2023, the three countries with the most expensive prices are: Sweden (180.28 USD), Switzerland (174.86 USD) and Denmark (171.35 USD). The three countries with the cheapest prices are: Iran (Islamic Republic of) (61.32 USD), Russian Federation (67.19 USD) and Poland (67.48 USD).

(d) 14 voucher TIR Carnet (Non-member/ Foreign)

11. In 2023, the three countries with the most expensive prices are: Switzerland (284.15 USD), Sweden (208.75 USD) and Denmark (190.39 USD). The three countries with the cheapest prices are: Iran (Islamic Republic of) (61.32 USD), Poland (67.41 USD) and Turkmenistan (68.52 USD).



Figure V Variation of the prices of the 6 voucher TIR Carnet (Member/National) (2014-2023)



Variation of the prices of the 14 voucher TIR Carnet (Member/ National) (2014-2023)





16. From 2014 to 2023, the price of the 14 voucher TIR Carnet, issued to non-member/foreign transporters, has decreased in the majority of countries where data is available for both years. However, the price has increased in Armenia, Moldova, Latvia, Belarus, Türkiye, Slovenia and Ukraine.

3. Correlations

17. This section looks at the correlation between the variation of the prices of 6 and 14 voucher TIR Carnets, issued to members/national transporters and non-members/foreign transporters, and the variation of the Gross Domestic Product (GDP) per capita⁴ from 2014 to 2023 (when data is available).


18. The correlation between the variation of the prices and the variation of the GDP per capita are positive for the 6 vouchers and negative for the 14 vouchers.

Figure IX 2024 prices of the 6 voucher TIR Carnet (Member/ National)




19. In 2024, the three countries with the most expensive prices are: Sweden (191.07 USD), Denmark (184.51 USD) and Syrian Arab Republic (165.00 USD). The three countries with the cheapest prices are: Türkiye (42.45 USD), Poland (43.08 USD) and Russian Federation (43.66 USD).






Figure XIV Variation of the prices of the 6 voucher TIR Carnet (Non-member/ Foreign) (2015-2024)



Figure XV Variation of the prices of the 14 voucher TIR Carnet (Member/ National) (2015-2024)





27. From 2015 to 2024, the price of the 14 voucher TIR Carnet, issued to non-member/foreign transporters, has decreased in the majority of countries where data is available for both years. However, the price has increased in Armenia, Moldova, Latvia, Belarus, Türkiye, Slovenia and Ukraine.

3. Correlations

28. This section looks at the correlation between the variation of the prices of 6 and 14 voucher TIR Carnets, issued to members/national transporters and non-members/foreign transporters, and the variation of the Gross Domestic Product (GDP) per capita⁵ from 2015 to 2024 (when data is available).

29. The correlation between the variation of the prices and the variation of the GDP per capita are negative for TIR Carnets issued to members/national companies and positive for TIR carnet issued to non-members/foreign companies.

IV. Disclaimer

30. The prices charged by the various issuing associations are not always comparable. Some associations report prices including taxes (e.g., VAT) and fees (e.g., insurance fees) while others do not include some or all of these taxes and fees in the prices they report. Furthermore, national practices, such as the obligation to deposit an amount of money with the association or the payment of annual membership fees, also have an influence on the prices charged for TIR Carnets.

V. Survey on TIR Carnet prices

31. At the request of TIRExB at its seventy-ninth session (ECE/TRANS/WP.30/AC.2/2019/11, para. 40), the secretariat circulated a new survey on TIR Carnet prices for the year 2019 (as contained in TIRExB Informal document No. 23 (2018)). The new survey clearly requests issuing associations to report the prices including all taxes and fees. The 2021, 2022, 2023 and 2024 surveys remained identical. Most issuing associations used the survey to provide their TIR Carnet prices.

VI. Considerations by the Board

32. In view of the above, the Committee may wish to take note the prices presented in Annexes I and II as well as the analysis of the 2023 and 2024 TIR Carnet prices..
