Jurisdiction in the field of Market Surveillance

Ministry of Internal and Foreign Trade-Market Inspection Sector:

- Low Voltage equipment (**LVD**)
 - Electromagnetic compatibility (**EMCD**)
 - Machinery (**MD**)
 - Radio equipment (**RED**)
 - Construction Products (**CPR**)
 - **ATEX**
 - Other product categories

- **General Product Safety and coordination in the National System for the exchange of Information on Dangerous Products**
 - **Support Product Safety Council in the coordination of Market Surveillance**

Role in combatting counterfeit products

Ministry of Internal and Foreign Trade-Market Inspection Sector apart from the control of product compliance and safety (Market Surveillance) is in charge of the Enforcement of Intellectual property Rights, especillay industrial property rights:

- ***Trademarks***
- ***Copyrights***
- ***Patents***
- ***Designs***
- ***Geografical indications***

Legal & Institutional framework has been established

Special powers of the competent IPR Enforcement Authorities

Ministry of Internal and Foreign Trade-Market Surveillance inspectors

- Perform inspection of production and commerce of goods infringing industrial property rights
- Start administrative procedure *ex officio* or at the request of the IPR holder –*Application for Action (AfA)*
- *Identify counterfeit goods and supply chain*
- *Provide evidence and samples - ask for expertise*
- *Undertaken temporary measures including the detention of goods with the reasonable suspicion of infringement of the protected IPR, that should be verified by a competent court*

Special powers of the competent IPR Enforcement Authorities

- **Out-of-court settlement**
- The competent authority should **exclude counterfeit or pirated goods from the circulation**
- **Final administrative decision**
- **Destruction of counterfeit and pirated goods**
- **Cooperation with IPR holder**
- Cooperation with the Market Surveillance Authority competent for ***dangerous waste and environmental protection*** and those competent for other risks depending on the kind of goods
