

83% of all turnover in Germany


Proportion of the turnover of all enterprise groups in the total turnover of the NSBR












All Enterprise Groups: Share of employment per class (old classification) relative to all Enterprise Groups

„enterprise groups size classes“




# „What do they do?“ – talking about activity codes

Green: activity of the Global Decision Centre


Orange: activity of the biggest enterprise

Brown: activity by NACE-algorithm



# Group dynamics: Continuity of groups

## Rommelspacher-Urban-metric for similarity

$$\text{Kombiniertes Ähnlichkeitsmaß}(A, B) = \begin{cases} a * \frac{\text{Anzahl } RE(A \cap B)}{\text{Anzahl } RE(A)} + b * \frac{\text{Anzahl } RE(A \cap B)}{\text{Anzahl } RE(B)} + c * \frac{\sum \text{Beschäftigten der } RE(A \cap B)}{\sum \text{Beschäftigten der } RE(A)} + d * \frac{\sum \text{Beschäftigten der } RE(A \cap B)}{\sum \text{Beschäftigten der } RE(B)} \\ 2a * \frac{\text{Anzahl } RE(A \cap B)}{\text{Anzahl } RE(A)} + 2b * \frac{\text{Anzahl } RE(A \cap B)}{\text{Anzahl } RE(B)} \end{cases}$$

Unter den Nebenbedingungen:  $a + b + c + d = 1$  und  $2a + 2b = 1$


Green: continuity

Blue: ambiguous continuity

Yellow: no continuity

$$\sum \text{Beschäftigten der } RE_A = 0 \text{ oder } RE_B = 0$$








# Talking about multinationals legal units


In terms of number of legal units

especially multinational groups


are a minor issue

Proportion of the legal units of all national and multinational enterprise groups in all legal units of the NSBR




# Talking about multinationals employment
