2. Highlights from the September 2024 session of the Global Forum for Road Traffic Safety (WP.1)

The Group of Experts will be informed about relevant activities of the Global Forum for Road Traffic Safety (WP.1) at its eighty-ninth session.

The Group of Experts may wish to be informed on the outcome of the discussion at WP.1 regarding the revision of the Group's Terms of Reference in light of the Inland Transport Committee (ITC) decisions at its February 2023 session.

3. Activities performed since the May 2024 session

The Group of Experts will be briefed on the outcome of the activity regarding the line-byline review of the existing international legal instruments on road traffic (the 1949 and 1968 Conventions, and for 2018 and 2022 Resolutions)

The Group of Experts may wish to resume the discussion related to (1) the term "Driver", (2) "Human roles when the ADS performs the DDT", (3) "Traffic rules set as driver/road user requirements", and (4) more generally road safety and automated driving: In doing so, the Group of Experts may wish to take into account the outcome of the line-by-line review of the Geneva and Vienna Conventions on Road Traffic, including the presentation drafted during the informal meeting in August 2024.
