# Proposal for Supplement 4 to the 09 Series of Amendments of UN Regulation No. 14 (Anchorages of safety-belts)

#### Submitted by the Working Party on Passive Safety\*

The text reproduced below was adopted by the Working Party on Passive Safety (GRSP) at its seventy-fifth session (ECE/TRANS/WP.29/GRSP/75, para. 30). It is based on ECE/TRANS/WP.29/GRSP/2024/7 as amended by annex VII to the report. It is submitted to the World Forum for Harmonization of Vehicle Regulations (WP.29) and to the Administrative Committee (AC.1) for consideration at their November 2024 sessions.

Paragraphs 5.1.1. to 5.1.1.2., amend to read:

- "5.1.1. The H point is a reference point as defined in Annex 4 of this Regulation, which must be determined in accordance with the procedure set out in that Annex.
- 5.1.1.1. Point H' is a reference point corresponding to H as defined in paragraph 5.1.1. which shall be determined for every normal position in which the seat is used.
- 5.1.1.2. The R point is the seating reference point defined in Annex 4 of this Regulation."
