

How we got to where we are (1)

- 2020: Steering Group proposed themes for task forces
- 2020 expert meeting (online) supported proposals
- November 2020: online survey gathered informal expressions of interest to participate
- January 2021: CES Bureau approved a high-level work plan for the project
- October 2021: CES Bureau approved terms of reference to formally establish the 13 groups

How we got to where we are (2)

- 2022: identified chairs, gathered members, each group developed detailed work plans
- Most started meeting late 2022
- 2023: developed comprehensive questionnaire on 2020round practices & experiences
- September-December 2023: fielded survey (thanks!)

How we got to where we are (3)



2024:

- Analyzed survey findings to identify implications for the Recommendations (summary publication and online platform forthcoming)
- Revised or newly drafted Recs content, based on
 - Survey findings:
 - how many countries complied with existing recs? If they didn't, why? Are they irrelevant, impossible to follow, at odds with competing influences/demands, insufficiently detailed, obsolete?
 - do countries do other things in their census that our recs don't cover (and should)?
 - Expert knowledge:
 - what has changed since previous round? Are there new standards, policy needs etc?
 - Editorial considerations:
 - More concise and easily translatable language, clearer when something is recommended vs described, better distinguishing definitions from explanatory notes, etc.

What happens next (1)

• At this expert meeting:

• Task forces present their drafts

(n.b. submitted end June 2024, before full P&R draft was available: some have identified small changes to align with P&R since then, not reflected in the official docs online)

- Participants (you!) offer feedback
- Not reopening major questions
 – these have been settled already by TFs and with input from last year's expert meeting
- But still time to comment on details
- Do they make sense for your country? Do they reflect your census design? Will you be able to implement them? Are they useful?

What happens next (2)

• After this expert meeting:

- By early December: TFs revise based on feedback
- December-early January: secretariat combines, edits and formats
- Mid-January 2025: submit to CES Bureau
- Q1 2025: CES-wide consultation
 - IMPORTANT: prepare your colleagues and your senior management for this. Consultation on a long document will take a long time!
 - Much better to receive your critique now than during consultation
- Once unanimously approved by all CES countries, CES endorses at June 2025 Plenary.
- 2030 Recs published later in 2025.


