**Subject:** Decision VII/8p (Spain) - invitation to open session at Committee's 84th meeting (Geneva, 17-20 September 2024)

Dear Colleagues,

In the light of the additional information regarding decision VII/8p provided by the Party concerned on 6 March and 5 September and the comments of the communicant of communication ACCC/C/2014/99 on 23 August, the Committee invites Spain, the communicants and observers to attend an online open session with the Committee at its upcoming eighty-fourth meeting (Geneva, 17-20 September 2024) to discuss the additional information received.

The open session will be held on **Thursday, 19 September 2024, from 10:30-11:30 CEST**. The provisional timeline for the meeting is available at: <https://unece.org/info/Environmental-Policy/events/387666>

During the open session, the Committee is expected to ask the Party concerned questions to clarify its understanding of Spain's applicable legal framework and administrative practice. The Committee may also highlight any aspects that it considers may not yet fulfil the recommendations in decision VII/8p. The online open session is intended to be an interactive question-and-answer session. It will not be necessary for the Party concerned, the communicant or observers to make formal statements.
