Issue-Based Coalition on Environment and Climate Change Note by the secretariat, UNEP and UNESCO, co-leads of the Coalition

Summary

This informal paper provides information to the United Nations Economic Commission for Europe (UNECE) Committee on Environmental Policy about environmental and climate-related activities of the United Nations system in Europe and Central Asia carried out by a coalition of United Nations entities.

The Committee might wish to take note of this information.

I. Introduction

- 1. The establishment of the United Nations Inter-Agency Issue-Based Coalition on Environment and Climate Change in Europe and Central Asia region (IBC) was first proposed at the Regional UN System meeting in May 2019. That meeting recognized that the region was facing numerous environmental challenges such as the unsustainable use of natural resources, vulnerability to climate-induced natural hazards and the impacts of climate change, air pollution, biodiversity and habitat loss and the need for better transboundary cooperation and decided to explore the opportunities to establish an IBC on environment and climate change.
- 2. Terms of reference for the IBC were presented to the Regional UN System meeting in December 2019 by the co-leads: UNECE, United Nations Environment Programme (UNEP) and United Nations Educational, Scientific and Cultural Organization (UNESCO). The meeting agreed that the IBC would be active as of January 2020.
- 3. The IBC provides a regional platform for UN agencies to:
- (a) Promote coordinated support to all Member States in Europe and Central Asia in their implementation of the 2030 Agenda for Sustainable Development, the Paris Agreement on climate change and other relevant multilateral environmental Agreements;
- (b) Support United Nations Country Teams (UNCTs) in the Europe and Central Asia region on environmental and climate change issues.
- 4. The Coalition is open to all UN agencies, funds and programmes. The current members are FAO, ILO, IOM, OHCHR, UN Habitat, UN Women, UNDP, UNDRR, UNECE, UNEP, UNESCO, UNFCCC, UNICEF, UNOPS, WFP, WHO and WMO. It is supported by the Regional Development Coordination Office.
- 5. A website¹ makes available materials developed, with links to video recordings of many thematic webinars. Products and events are listed in annex to this document.
- 6. In total, the UN System in Europe and Central Asia region has set up seven Issue-based Coalitions, and two other thematic groups clustered around cross-cutting policy issues. These are overseen by the Regional Collaborative Platform for Europe and Central Asia (RCP).

II. Main areas of activity

7. The activities of the IBC are organized under three pillars and are undertaken in response to requests by UNCTs, Resident Coordinator Offices (RCOs) or Resident Coordinators (RCs) themselves in UN programme countries, or the RCP.

Pillar 1: Strengthening environmental and climate change governance and implementing the SDGs and the 2030 Agenda

- 8. The IBC aims to build political momentum and advocate for enhanced and accelerated policy action to implement the environmental and climate change dimension of the SDGs and the 2030 Agenda and enhance the ambition of the nationally determined contributions (NDCs) further to the Paris Agreement, in addition to advocating for environmental and climate change issues at the regional level, including through relevant regional intergovernmental processes, and with regional institutions such as the European Commission and the Commonwealth of Independent States.
- 9. The IBC focuses on working with UNCTs to strengthen national institutions responsible for environmental and climate change policy and governance, as well as to strengthen country capacities to accede to, implement and report on multilateral environmental and climate change agreements. In particular, the IBC:
- While using existing environmental and climate change processes and in collaboration with regional
 institutions, advocates at the regional level for strengthened and accelerated policy action and transition
 pathways to address regional priorities, such as enhanced ambition for climate change mitigation and
 adaption, nature-based solutions, circular economy, just transitions and decent work, decarbonization
 and net-zero strategies, sustainable consumption and production, sustainable infrastructure and both
 sectoral and cross-sectoral approaches.
- Identifies key institutional and governance challenges for the environment and climate change within
 the programme countries, such as inter-institutional cooperation, enhancement of legal and regulatory
 frameworks, stakeholder engagement and human rights, and exchange good practice principles and
 approaches with the UNCTs. Also, links with intergovernmental processes, such as the Generation
 Equality Action Coalitions ("Feminist action for climate justice") and the UNFCCC Gender Action
 Plan, which can serve as accountability tools.
- Assists UNCTs in strengthening country capacities to accede to, implement and report on global and regional multilateral environmental and climate change agreements.
- Examines environmental and climate risks and provides guidance on preparedness, prevention and risk reduction measures.

Pillar 2: Supporting countries in the environmental and climate change dimension of UN Sustainable Development Cooperation Framework (UNSDCF) and Common Country Analysis (CCA) processes

10. The IBC aims to build on many other parallel supporting processes, such as UN custodian agencies for environment-, weather-, water-, climate change- and health and well-being related global indicator reporting to UN Statistical Division, the Secretary General's annual report, the Global Sustainable Development Report, Sendai Framework reporting, UNEP's Global Environment Outlook, the work of the human rights treaty-bodies, the Universal Periodic Review and the special procedures mechanisms of the Human Rights Council, the Shared Environmental Information System, other issue-based coalitions, Mainstreaming, Acceleration and Policy Support (MAPS), environmental performance reviews and state-of-the-environment reports. In particular, the IBC:

- Creates a roadmap and schedule of various events and critical dates in country led UNSDCF processes to enable the pro-active involvement of the IBC to support UNCTs in programme countries.
- Applies a systematic approach to engage and inform the development and content of the CCAs, using
 the CCA companion to the UNSDCF Guidance, while recognizing the specific positions and roles of
 men and women and the importance of not perpetuating gender inequalities, and that CCAs and
 UNSDCFs should be based on circularity, equality and inter-generational solidarity and include
 systemic risk identification, assessment and reduction, when needed.

- Works with UNCTs to ensure environmental and climate change priorities are properly identified and
 presented in the CCAs for the programme countries in the region, with an initial focus on the countries
 implementing UNSDCF processes in 2020.
- Develops and maintains an IBC menu of services for UNCTs and other stakeholders, related to the
 environmental and climate change dimension of SDGs, across the UN system, based on the demands
 of RCs and UNCTs and on the capacities of the IBC members.

Pillar 3: Monitoring and reporting on the environmental and climate change dimension of SDGs

- 11. The IBC aims to share and streamline scientific data and information and existing tools across the UN family, with a focus on the implementation of the environmental and climate change dimension of the 2030 Agenda and the SDGs in Europe and Central Asia (while fully acknowledging the integrated nature of environment, social, health, economic and governance aspects).
- 12. This work includes reporting and follow-up (of data, statistics, indicators and Voluntary National Reports), which are critical inputs to the High-level Political Forum on Sustainable Development, with the purpose of supporting the regional UN system in building national capacity in countries for delivering on the 2030 Agenda and the SDGs. In particular, the IBC:
- Informs UNCTs preparing the CCAs about, and shares with them, relevant environmental and climate change data, statistics, existing tools and assessments, at both the national level and through global, regional and thematic assessments.
- Advises on what environment- and climate change-related knowledge products should be made
 available on the UN Regional Knowledge Management Hub 3 and ensures close cooperation with the
 Regional UN Coordination Group on Data and Statistics and the Issue-based Coalition on Gender
 Equality, among others, in the creation of new knowledge.

III. Themes

- 13. To date, the major themes have been:
- Mainstreaming of environment and climate change into UNSDCFs and CCAs, including guidance and training events
- Green transitions, including a five-part training series, but also within more targeted webinars
- Transboundary water cooperation and reviewing water-related activities in subregions
- Climate change, biodiversity loss and pollution (air)
- Disaster risk reduction
- Links with social issues such as leaving no one behind, a just transition and education
- Greening the post-pandemic recovery
- Peer-learning roundtables on the above themes during the Regional Forum on Sustainable Development.

IV. Resources

- 14. The IBC is resourced by concerned staff taking on additional tasks, i.e. within existing resources and as an in-kind contribution.
- 15. Occasionally, members of the Coalition finance consultants to undertake studies or travel. In UNECE, this has been possible with targeted funding from the Regular Programme on Technical Cooperation, for example, of subregional reviews of UN initiatives on water cooperation and regional training webinars on the mainstreaming guidance and green transitions. In UNEP, this has been possible with core funding for Enhancing capacity of the RCOs and UNCTs, for example, on mainstreaming of biodiversity into CCAs and UNSDCFs across the region. In UNESCO, this has been possible through extrabudgetary funds.
